### Action Items:

### Discussion Items:

- Youth Committee Action Plan

The Committee reviewed the Youth Committee Action Plan status noting progress on the Committee's goals. The Committee discussed a proposed Youth Lead Summit to be held in March 2011 and related issues such as whether to have separate Summits for Pasco and Hernando county or to hold one joint Summit, the location of the Summit, whether separate or joint, possible dates, transportation, funding, etc. It was decided that many of these issues would be discussed and decided on during the upcoming Education Committee and HYI Steering meetings, and that those decisions would be shared with the Youth Committee at the next scheduled meeting.

The Committee decided that with the interest in the proposed Youth Summit and the extensive planning required to organize such an event, the Youth Committee should meet in January and February and decide the frequency of meetings after the Youth Summit.
